#### Overview

Resimac Asset Finance Pty Ltd, ACN 098 034 041 ('we', 'us', 'our') collects information about you for the purposes of arranging or providing credit. You consent to us and some other entities collecting, using, holding and disclosing personal and credit information about you. This document also tells you about our privacy practices. When you sign below, you agree we can, consistently with Australia's privacy and credit reporting laws, collect, use and exchange credit and personal information about you.

#### Privacy disclosure statement and consent

We are collecting credit and personal information (information about you), for the following purposes:
